

AWTY LOGISTICS, LLC PRODUCTS: AWTY COMPASS™ / AWTY UMAP™ / AWTY TICKET™ / AWTY MAPS™
END-USER LICENSE AGREEMENT (EULA)

This is a legally binding agreement between you (either an individual, single entity or company), referred to herein as "YOU", and AWTY LOGISTICS, LLC, referred to herein as "AWTY" or "DOCUMENTS", "PRODUCTS".

All AWTY Compass® and AWTY UMap® navigation applications or inferences, including all documents and materials associated with any and all products/subscriptions therein, are referred to herein as "AWTY PRODUCTS".

Using all or any portion of AWTY PRODUCTS indicates your acceptance of all the terms and conditions of this End-User License Agreement referred to herein as "EULA" and that this agreement is equivalent to a written agreement signed by you. By either selecting "I AGREE & ACCEPT" or "AGREEING TO TERMS" via clicking 'continue' or 'next' or performing a similar electronic function, you are providing your acceptance of the terms of this agreement. This agreement is enforceable against you and any entity that has obtained AWTY PRODUCTS and on whose behalf, it is used. If you do not agree to the terms of this agreement, please do not purchase or use AWTY PRODUCTS.

IT IS ILLEGAL THROUGH AND STRICTLY PROHIBITED TO SHARE SUBSCRIPTION INFORMATION OR PASSWORDS, OR TAKE PHOTO'S, PHOTO COPY, PUBLISH, DISTRIBUTE, OFFER FOR SALE, LICENSE OR SUBLICENSE, GIVE OR DISCLOSE TO ANY OTHER PARTY, ANY PORTION OF AWTY PRODUCTS OR ASSOCIATED DOCUMENTS IN HARD COPY, DIGITAL FORM OR ANY OTHER MEDIUM WHETHER EXISTING OR NOT YET EXISTING, EXCEPT AS SPECIFICALLY PERMITTED BELOW.

The use of AWTY PRODUCTS are governed by the terms and conditions set forth herein. Please read them carefully. This EULA is applicable to all of the DATA OR DOCUMENTS (physical and digital) included with AWTY products in whole or part. You are deemed to have read, understood and accepted the terms of this EULA.

1. LIMITED LICENSE. You are granted a limited, non-exclusive license to purchase subscriptions (either through a Master Service Agreement or Individual subscription process) to view on individual computers, smart phones or tablets, for your own use provided that such computers do not render AWTY MAPS accessible to other users outside your individual or company subscription agreement, through shared, local or Internet networks or other methods. Only the individual or company that has purchased an AWTY subscription(s), will have the license to use the aforementioned products based on their per user use information. Use by any other person, company, affiliate, corporation, Limited Liability Company, trust, or other separate legal entity will require a separate subscription or Master Services Agreement purchase. This includes companies that may be affiliated to you by ownership or otherwise. The agreement stated herein shall remain in effect perpetually, but shall terminate upon your violation of any term or condition hereof. All protections with which AWTY is provided under this EULA shall survive the termination of your use.

2. PROPRIETARY RIGHTS. AWTY Logistics, LLC, retains all title, ownership, and intellectual property rights, including but not limited to all supporting documentation, files, marketing material, images, multimedia and applets. AWTY Logistics and AWTY PRODUCTS are protected by copyright, trademark, trade name, and other intellectual property laws. AWTY PRODUCTS may include security measures designed to control access and prevent unauthorized copying, access and use. You agree not to interfere with any such security components. AWTY permits you to view, use, or otherwise benefit from the functionality or intellectual property of its physical maps or software applications (AWTY UMap, AWTY Compass, AWTY Ticket) only in accordance with the terms of this EULA. Use of third party material included in the maps, applications or software may be subject to the terms and conditions typically found in the party's own license agreement.

3. CONFIDENTIALITY. Each party agrees that it shall not disclose to any third party any information concerning customers, trade secrets, methods, processes or procedures or any other confidential, financial or business information of the other party which it learns during the course of its performance of this EULA, without the prior written consent of such other party. This obligation shall survive the cancellation or other termination of this EULA. The DOCUMENTS contain trade secrets and proprietary know-how that belong to AWTY and it is being made available to you in strict confidence. ANY USE OR DISCLOSURE OF AWTY TRADE SECRETS, PROPRIETARY DATA, SOFTWARE PROCESS OR OF ITS ALGORITHMS, PROTOCOLS OR INTERFACES, OTHER THAN IN STRICT ACCORDANCE WITH THIS EULA, MAY BE ACTIONABLE AS A VIOLATION OF AWTY TRADE SECRET RIGHTS.

4. NON-TRANSFER OF RIGHTS. You may not rent, lease, sell, sublicense, assign or transfer your use rights, or authorize any portion of the AWTY PRODUCTS OR DOCUMENTS to be laminated, photo copied, or copied onto another individual or legal entity's computer, phone, or camera.

5. ALLOWED USAGE. Upon fulfilling your obligations towards properly purchasing AWTY's software subscriptions, or obtaining valid viewing privileges of ANY physical maps, you are permitted to do only the following:

(a) Use the products for discerning road route selection (however, final route selection is the sole responsibility of the user), in which you are one of the parties are interested. You are encouraged to obtain competent legal counsel to advise you on the use of the Documents and/or the contractual relationship you are establishing based on this data.

(b) If you are an attorney, you may review the Documents and use them only for preparing documents for your immediate clients (whom have purchased AWTY PRODUCTS or subscriptions) with whom you have an attorney-client relationship.

(c) With prior authorization from AWTY, the DOCUMENTS may be included in the packaging and shipment of your product or in your product documentation Documents that are meant to be distributed. You may not otherwise duplicate AWTY PRODUCTS. You agree that any copy of the DOCUMENTS which you make pursuant to this EULA shall bear all copyright, trademark and other proprietary notices included therein by AWTY Logistics, LLC and, except as expressly authorized herein, you shall not distribute the same to any third party without AWTY's prior written consent.

6. DISTRIBUTION. You may not export, remove or distribute AWTY PRODUCTS in any way, except as prescribed by the Allowed Usage defined in Section 5. Distribution of AWTY PRODUCTS is allowed, provided AWTY has given you prior written authorization and that all trademarks, ownership and copyright notices remain in and with the DOCUMENTS

7. RESTRICTIONS. You may not: (i) modify or create any derivative works of the DOCUMENTS, including customization, any modifications or enhancements, translation or localization without AWTY's express written consent; (ii) reverse engineer, decompile, disassemble, make or otherwise attempt to derive a unique duplication of AWTY PRODUCT (physical or digital) or the underlying ideas or algorithms of any software; (iii) attempt to gain unauthorized access to servers or any other service, account, computer system or network associated with AWTY, its affiliates, agents, partners and customers; (iv) remove or alter any trademark, logo, copyright or other proprietary notices or symbols of the DOCUMENTS; (v) block, disable, or otherwise affect any advertising, banner window, tab, link to websites and services, or other features that are part of AWTY; (vi) incorporate, integrate or otherwise include any DOCUMENTS or PRODUCTS portion thereof into any software, program or product; (vii) provide false information when purchasing AWTY PRODUCTS or software; (viii) digitally transmit or make available AWTY PRODUCTS or its content through local networks, intranets, extranets, FTP, online discussion boards, forums, list-serve, peer-to-peer networks or technologies, newsgroups, bulletin boards, or any other mode of shared communication system, or place any DOCUMENTS onto a server so that it is accessible via a public network such as the Internet/Intranet; (ix) use the DOCUMENTS in any way that violates this EULA or any law; or (x) authorize or assist any third party to do any of the things described in this section.

9. SOFTWARE LICENSE. Certain features or content of AWTY PRODUCTS may require the purchase of AWTY Activation or Subscription approvals. You agree not to attempt to, and not to, control, disable, modify or remove any component of the licensing protection system. You also agree not to access, attempt to access, copy, share or distribute the license subscriptions for any purpose.

10. SOFTWARE UPDATES. AWTY COMPASS is configured to automatically check for updates. By using AWTY Compass, you consent to receiving software updates, modifications, and/or patches that address issues such as security, interoperability, and performance. Your use of the updates shall be governed by this EULA unless you are asked to agree to a new EULA at the time of download or installation.

11. PRIVACY

(a) SOFTWARE ENHANCEMENT PROGRAM. By participating in the AWTY Compass Software Enhancement Program, you allow AWTY Compass to collect anonymous information relating to your use of the software, such as the frequency of use and of certain features, and information on errors occurring during your use of the software. This anonymous usage data will be used to diagnose performance issues and improve the reliability of the software and its features. This data will not be tied to any information that would personally identify you.

(b) PERSONAL INFORMATION. During the AWTY Compass installation process, or at some time thereafter, you may be asked to provide certain information that will be used to personalize certain Documents, send you AWTY Compass information via email, mail or text, and customize some information presented to you through the software.

For example, you may be asked for your county/state/province/country, which could be used by the software to provide you with locally relevant Documents and/or related products. All personal and billing information is transmitted using the secure SSL protocol. Both personal and non-personal information collected by the software is safeguarded according to the highest privacy and data protection standards adopted worldwide, and will not be shared or given without your consent as described in our Privacy Policy (available at [INPUT LOCATION OF DOCUMENT ON AWTY WEB PAGE LINK](#)).

12. LIMITATION OF LIABILITY. EXCEPT AS REQUIRED BY LAW, AWTY MAPS AND ITS EMPLOYEES, DIRECTORS, LICENSORS, CONTRIBUTORS AND AGENTS WILL NOT BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES ARISING OUT OF OR IN ANY WAY RELATING TO THIS EULA OR THE USE OF OR INABILITY TO USE AWTY PRODUCTS OR DOCUMENTS, INCLUDING WITHOUT LIMITATION DAMAGES FOR LOSS OF GOODWILL, WORK STOPPAGE, LOST PROFITS, LOSS OF DATA, AND COMPUTER FAILURE OR MALFUNCTION, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF THE THEORY (CONTRACT, TORT OR OTHERWISE) UPON WHICH SUCH CLAIM IS BASED. AWTY MAPS LIABILITY UNDER THIS EULA IS LIMITED TO REPLACEMENT OF PRODUCT OR DOCUMENTS AND WILL NOT EXCEED TEN DOLLARS (US\$10.00)

13. DISCLAIMER OF WARRANTY. YOU ACCEPT THE DOCUMENTS "AS IS" AND WITH ALL FAULTS (IF ANY). AWTY LOGISTICS, LLC DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. AWTY PRODUCTS MAKES NO WARRANTY OR REPRESENTATIONS WHATSOEVER REGARDING THE CONTENT OF THE PRODUCTS AND YOUR USE OF THE DOCUMENTS, OR THE SUITABILITY OF WHICH TO MEET YOUR SPECIFIC NEEDS. 14. VIOLATIONS OF THIS EULA. AWTY reserves all rights not specifically granted to you above. AWTY will have the right to proceed against you in the event that you infringe against AWTY rights. Any use not within the precise scope of the agreement set forth herein will be considered an infringement. You acknowledge and agree that AWTY damages in the event of your violation of this EULA will be substantial and that AWTY will suffer irreparable harm in such event. As such, AWTY shall have the right to obtain equitable remedies, including but not limited to recovery of damages, obtaining injunctions, recovering statutory damages, recovering attorney fees, and any other available legal remedy.

15. TERMINATION. AWTY shall have the sole and exclusive right to immediately terminate this EULA and suspend your permissions to use the PRODUCTS or DOCUMENTS should you fail to perform any obligation required under this EULA, engage in activity that AWTY deems harmful to its well-being or if you become bankrupt or insolvent. This EULA takes effect upon your purchase of the PRODUCTS or DOCUMENTS and remains effective until terminated. Upon termination of this EULA by AWTY, you shall return to AWTY the original or copies of the PRODUCTS or DOCUMENTS including partial copies and modifications.

16. WAIVER & SEVERABILITY. AWTY waiver of any breach of this EULA shall not constitute an amendment to this EULA or AWTY waiver of subsequent breaches. If any part of this EULA is found void and unenforceable, it will not affect the validity of the balance of this EULA, which will remain valid and enforceable according to its terms.

17. RESTRICTED RIGHTS LEGEND FOR GOVERNMENTAL USE. AWTY in its whole, like any software, or other information that is downloaded through accessing AWTY PRODUCTS or DOCUMENTS via its website (web maps), partner websites and download sites for or on behalf of the United States of America, its agencies and/or instrumentalities ("U.S. Government"), is provided with Restricted Rights. Use, duplication, or disclosure by the U.S. Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs (c)(1) and (2) of the Commercial Computer Software--Restricted Rights at 48 CFR 52.227-19, as applicable.

18. ELECTRONIC NOTICES. You consent that AWTY may provide you with information and notices regarding the PRODUCTS or DOCUMENTS and AWTY via the email address you designate when purchasing the PRODUCTS or software or thereafter. AWTY may provide notices to you via (i) email if you have provided AWTY with a valid email address, or (ii) by posting the notice on the AWTY website or the software download site which AWTY owns and operates. You may withdraw your consent for electronic notices.

19. AMENDMENTS. AWTY reserves the right to unilaterally amend all offers, pricing terms or other matters pertaining to the DOCUMENTS, AWTY website or this EULA. No course of dealing or trade usage shall be deemed to amend the terms of this EULA.

20. GOVERNING LAW. This EULA shall be governed by and construed under the laws of the State of Colorado. You consent and agree that all legal proceedings relating to the subject matter of this EULA shall be maintained in courts sitting within the State of Colorado, and that jurisdiction and venue for such proceedings shall lie exclusively with such courts.

21. COMPLETE AGREEMENT. This is the entire EULA between AWTY and you relating to AWTY COMPASS™ / AWTY UMAP™ / AWTY TICKET™ / AWTY MAPS™, which supersedes any prior representations, discussions, undertakings, warranties, communications or advertising relating to the PRODUCTS or DOCUMENTS.
